 System (UAS) to record on campus, it is therefore prohibited to use such a system to
 produce a video for this competition. Any video made by UAS would not be accepted.
- The contestant shall grant the usage rights, including renaming, copying, editing, distributing, broadcasting of parts or/and all footage of the entry, to Chung Chi College, The Chinese University of Hong Kong.
- The entry must not contain obscene, violent, pornographic, defamatory, objectionable, insulting, or any of the controversial and inappropriate content.
- All decisions made by the judging panel are final.
- Chung Chi College has full authority to make final decisions in all matters related to this
 competition, including the terms and regulations, prizes, and other arrangements
 without prior notification.
