RELS5273: Catholic Social Ethics 天主教社會倫理

### **Course Description:**

This course introduces Catholic Social Ethics. First, it gives an overview of its theological foundations, its relation to broader traditions of Catholic ethical thought, and its historical development from the early Church to the present, in particular the formation of the Catholic Social Teaching. In turn, the four fundamental ethical principles, human dignity, solidarity, subsidiarity, and the common good are discussed. It then considers particular topics in Catholic Social Ethics such as: marriage and family; the meaning of work and its relation to the economy; immigration; the political community; the international community; the environment; war and peace.

## **Learning Outcomes:**

Enable Students to

- 1. Understand and analyze the sources and principles of Catholic Social Ethics
- 2. Understand and evaluate the historical development of Catholic Social Ethics
- 3. Evaluate the Catholic ethical principles applied in contemporary ethical issues
