MA Research Paper is an elective course, designed specifically for students who would try to work independently on a topic of their own choice. To a large extent, this is a self-taught course, even though there will be group and individual supervision to guide you through from start to finish. Given the constraint of time, student initiative is most important.

• Group Meetings: Students who join this elective course need to attend 2-3 group meetings; and the date for the second and third meeting will be set during the first meeting. The purpose of these group meetings is for students to share, discuss and present initiate research topic(s), method, and literature review. Individual Consultations: In addition to the 3 required progress consultations during Week 6 and Week 10, students are welcome to arrange other meetings with your supervisor(s).

Progress reports: Written portions of the Research Paper must be handed in to supervisor during the weeks required for assessment related consultations.

Week 6 Meeting: students are required to produce at least one sizable written section of the proposed research paper (no need to submit on VeriGuide. Put a hard copy in my mailbox 24 hours before the meeting).

Week 10 Meeting: at least half of the length required should be submitted (no need to submit on VeriGuide. Put a hard copy in my mailbox 24 hours before the meeting).

MA Research Paper: The length of the Paper should be 8000-15000 in English; 12000-20000 in Chinese. For format and other requirements consult Department's website.

Deadline for submitting the Research Paper will be at midnight 23, April, 2019. Students have to upload a softcopy to the 'VeriGuide', as well as hand in a hardcopy with a signed Academic Honesty Statement to mailbox of their supervisors in KKL 3/F. Late submission will be penalized.

The Chinese University of Hong Kong places very high importance on honesty in academic work submitted by students, and adopts a policy of zero tolerance on cheating and plagiarism.
