CURE 3378: Fieldwork in Islamic Culture and Religion in Turkey

Course Description

This course aims to introduce students to the history, Islamic culture and religion of the Turkey. It offers students a lively and experiential learning experience on Islam through fieldwork in both Hong Kong and Turkey. We will be (1) visiting mosques and Islamic centers in Hong Kong on one Saturday and (2) going on a weeklong visit to Turkey in March that will include visiting religious, cultural, and historical sites. Students will learn through first-hand exposure to religious sites, material culture, and observation of the daily life of and personal interactions with practitioners of Islam. The visit of sites will be organized and led by the teaching staff. Students are required to attend seven lectures before our visit to Turkey.

Course Content and Schedule

There will be seven class meetings for lectures and discussions conducted on campus prior to the fieldwork. The lectures and discussions will offer students an overview of the geographical, philosophical, religious, socio-political and historical background of the sites that will be visited and the traditions we will interact with. All students should, <u>as a course requirement</u>, join the weeklong trip to Turkey during the Reading Week (3-8 March, specific dates TBD). It should be noted that student must pay for their own expenses for the Turkey trip (about HK\$ 8,000) which is also subsidized courtesy of the Islamic Cultural Association in HK <u>http://www.ica.org.hk/</u> and the Department of Cultural and Religious Studies. Class enrolment is limited to 25.

Course Requirements

To register in this course, students <u>must</u> be able to join all fieldtrips in Hong Kong and the trip to Turkey in March 2025. Students have to (1) hand in a literature review before the trip to Turkey, (2) perform a group presentation with PowerPoint. Failure to do so will result in losing all the credits for the course or in losing substantial marks from the final grade.

Assessment Scheme

Fieldwork will add up to approximately 75 hours of off-campus learning which will include on-site lectures, on-the-spot investigations, and discussions during the trip.

Paper 50%

Each student must choose at least three (3) books from and/or relevant academic journal articles, and produce an essay summarizing the contents and analyzing the key arguments of the books in relation to a particular research topic. The **first draft** of the paper ("Literature Review", 1,000-1,250 words) is to be submitted by 5:00 p.m. 2 March. The **final draft** of the paper, fully edited with a conclusion based on fieldwork, approx.. 2,000 words) is due by **11:59, 6** April.

Papers must be typed, double-spaced (Times New Roman, 12 pt. font). Grammar, punctuation, style, and content will be factored in the grading of the essay, so be sure to proofread before submitting the paper. Papers should be sent by e-mail, attached as a MS Word Doc with your name on the file. E-mail to the professor and your tutor, along with the **VeriGuide receipt**. The paper must be submitted by **6 April 2025, 11:59 p.m.** Unless a deadline extension is granted with prior permission from the professor, late submissions will be penalized.

Presentation (& Response) 30%

Students will break into groups with each group consisting of 5 students. Each group will present for 40 minutes. Presentation topics may be chosen from the list below, or may be proposed by the group with the professor's approval.

- (1) Islam, Charity, and Finance
- (2) Gender and Women's Issues
- (3) Islamic Arts and Architecture
- (4) Islam, Politics, and Secularism
- (5) Ethnic and Religious Pluralism in Turkey
- (6) Turkish International Relations: East and West

The presentation will be after we return from the trip to Turkey. Each group should also submit via email one **narrative written summary** to go with the PowerPoint and will be asked to give a **response to a presentation** of another group.

Participation 20%

Your attendance, participation in class, tutorials, presentations and the fieldtrip will count as 20% of the course grade.

Things to Note for the Turkey Trip

Visas: For holders of a Hong Kong SAR no advance visa arrangements are required to visit Turkey. When you arrive at Istanbul Airport and proceed to Immigration, your passport will be stamped with a 30-days visit visa free of charge. Holders of a PRC passport must apply for an e-visa online (https://turkey-e-visa.com/turkey-visa-for-china-citizens/) before departure. Holders of other nationalities' passports should consult the website: <u>https://turkey-e-visa.com/</u>

- Electric plugs and sockets for Turkey are European type with 2 round legs.
- Weather for Turkey in March is mostly sunny and dry, with an average daily temperature around 13-7 °C.
- Do **not** wear tight pants or mini-skirts; skirts & pants should be at least of knee length.
- Women have to wear *hijab* or headscarf while entering mosques.
- It is recommended to wear slip-on type of shoes as you need to take off your shoes when entering mosques and do not bring expensive footwear. Bring slippers as needed.
- No alcohol or smoking during the trip, please.
- Bring face masks, hand sanitizer and suntan lotion as needed.
- You will be covered by group insurance.
- You may want to bring Turkish Lira (TRY) equivalent to US\$400 for personal shopping.
