Summary Report of the 7th (2023) Council Meeting (31st October, 2023)

- 1. The Council HEARD a verbal report on the further progress in reviewing the draft constitution of The Chinese University of Hong Kong Student Union.
- 2. The Council HEARD a verbal report from the Chairman of the Council on the attendance of the meetings of the Legislative Council Bills Committee.
- 3. The Council RECEIVED a verbal report from the Vice-Chancellor on the recent developments and activities at the University, including
 - (a) Times Higher Education Asia Universities Summit co-hosted by the University;
 - (b) Vice-Chancellor's Chairmanship of the Association of Pacific Rim Universities since August 2023;
 - (c) CUHK Presidents' Forum to be held in late 2023;
 - (d) Six Mainland bases in 2023 to promote industry-academia-research collaborations and advance national innovation agenda;
 - (e) Global Conference on Sustainable Development in early October 2023;
 - (f) China's 40th Antarctic Scientific Expedition;
 - (g) Tissue Engineering and Regenerative Medicine International Society Asia Pacific Conference 2023;
 - (h) Nobel Prize in Physiology or Medicine 2023; and
 - (i) Business handled by the Vice-Chancellor under delegated authority.

- 5. The Council APPROVED the draft Report of the Council to be incorporated in the Annual Report of the University 2022-23, in compliance with the requirement of the Statement of Recommended Practice for the UGC-funded universities.
- 6. The Council APPROVED the appointment of KPMG as Auditor of the University for the financial year 2023-24.
- 7. The Council RECEIVED the audited Financial Statements of the Staff Superannuation Scheme (1995) and the Terms of Service (C) Staff Terminal Gratuity Scheme for the year ended 30th June, 2023.
- 8. The Council APPROVED the re-appointment of Professor Tang Xiaobing as Dean of the Faculty of Arts for a further term of five years with effect from 2nd September, 2024.
- 9. The Council RECEIVED a PowerPoint presentation on the progress report on the development of CUHK Medical Centre.

- 11. The Council APPROVED the appointment of Mr. Nicholas H.F.
