## Second Meeting (2024-25)

The second meeting in the 2024-25 academic year of the Senate was held on 4 December 2024. The following major items were dealt with (not including business regarded as in the reserved area) at that meeting.

The recommendation of the Senate Committee on Sub-degree, Professional and Continuing Education Programmes to phase out the Professional Certificate Programme in Promoting Well-being in Informal Caregivers of Dementia with immediate effect was approved.

The study scheme and exemptions from Major requirements of the Bachelor of Arts Programme in Public Humanities for senior-year entrants with effect from 2025-26 were noted.
