Keynote Speakers**王紹光 (Wang Shaoguang)**

Dr. WANG Shaoguang is Chairperson and Professor of Department of Government and Public Administration, CUHK, and the Director of the Universities Service Centre for China Studies. He is also a Changjiang Professor in the School of Public Policy and Management at Tsinghua University, non-official member of the HKSAR's Commission on Strategic Development, and chief editor of The China Review, an interdisciplinary journal on greater China. He taught at Yale University in the United States from 1990 to 2000. His research interests include political economy, comparative politics, fiscal politics, democratization, and economic and political development in former socialist countries and East Asian countries. In addition, he has contributed to numerous edited volumes and journals.

Pierre Landry (李磊)

Dr. Pierre Landry is Associate Professor of Political Science at Yale University. He is also a Research Fellow at the Research Center for the Study of Contemporary China at Peking University. His undergraduate training was in Economics and Law at Sciences Po in Paris,, he received his Ph.D in Political Science at the University of Michigan. He is also an alumnus of the Hopkins-Nanjing program and taught in the Yale-Peking university joint undergraduate program in 2007. His research interests focus on Chinese politics, comparative local government, quantitative comparative analysis and survey research. His recent articles have appeared in Political Analysis and The China Quarterly. He is a consultant at our Universities Service Centre for China Studies where he participates in the development of the Barometer on China's Development (BOCD), a project which aims to build a multidimensional GIS database of county and city development in China. Dr. Landry's research has focused on the political management of cadres in China, looking at both the CCP's Formal and Informal channels control over local elites. He published a book *Authoritarianism and Decentralization: The Party and Local Elites in Post-Deng China*, by Cambridge University Press (2008). He is currently researching a book manuscript on the development of legal institutions in china, tentatively titled "Nurturing fragile institutions".

黃博士是英國牛津大學當代中國研究中心及賽德商學院高級研究學者。黃博士于麻省理工學院取得經濟學士學位，於伯克利加州大學取得經濟博士學位。在加入牛津大學前，黃博士曾為華盛頓大學亨利傑克遜國際研究院亨利傑克遜教授（2000-07），世界銀行高級經濟學家，亞洲開發銀行（馬尼拉）人駐行學者，曾任教於聖克魯斯加州大學，伯克利加州大學，及 Mount Holyoke College (Massachusetts)。黃博士專研中國財政及公共服務改革，題目包括中國經濟改革、財政改革、農村工業化和中央地方聯繫。最近出版著作有（與舒繡文教授合著） *Paying for Progress in China: Public Finance, Human Welfare and Changing Patterns of Inequality* (Routledge, 2007) 及多份世界銀行出版的中國財政政策研究報告，包括《改善農村公共服務》(中信, 2008); *China: Improving Rural Public Finance for the Harmonious Society* (2007); *Reforming Intergovernmental Finance in China: a Study of the*

宋永毅 (SONG Yongyi)

宋永毅教授現任美國加州州立大學洛杉磯分校圖書館的技術服務和收藏部主任。他從 1995 年起任職於美國圖書館和東亞研究界，並榮獲多項獎勵和榮譽：2006 他獲得「美國視覺藝術家協會」頒發的「言論自由捍衛者獎」；2005 年獲得美國圖書館協會的年度「勇氣獎」；2004 年獲得美國 Syracuse 大學資訊學院的「21 世紀全國圖書館館員獎」。他在 2002 年登入英國劍橋出版的“Who is Who in the 21st Century”，以及 2005-2009 年度美國的“Who is Who in America”。爲了向中國的當代歷史負責，1998 年以來，宋永毅組織了一批美籍華裔的圖書館館員和教授組成了「文化大革命光盤/網絡數據庫」編委會，開始了這一里程碑式的圖書檔案工程。爲搶救歷史檔案，宋永毅和他的夥伴們走遍了全世界的亞洲圖書館，並訪問了人數衆多的私人收藏家，收集文化大革命的文獻資料。這套「文化大革命光盤/網絡數據庫」終於由我們中國研究服務中心委托香港中文大學出版社于 2001 年出版。其間也有前中心主任關信基教授、助理主任熊景明的遠見和支持。現在，他又和他的夥伴們一起在我們中心的支持下進行「1957 年反右運動光盤/網絡數據庫」的編撰工作，他的努力讓當代和後人可以更接近真實地瞭解中國社會變遷中的一段不能越過、也不能忘卻的歷史過程。宋永毅近年來發表了大量有關文革的中英文著作：他與人合著的英文版《中國文化大革命大辭典》已經於 2006 年問世。

劉欣 (LIU Xin)

Dr. LIU Xin is Professor and Chairman of Department of sociology, Fudan University. He received his Ph.D from the Chinese University of Hong Kong in 2005. His areas of studies concern China's economic reform and changes in class structure, the emerging middle classes and their social attitudes, housing inequality, distributive justice, and quantitative research methods. He is currently the chief expert of the major research project "Social Stratification in Contemporary China" funded by Social Science Foundation of Ministry of Education of PRC (2008-2012), investigator of "Social Stratification and Distributive Justice" founded by National Social Science Foundation of China (2007-2009), and "The Institutional Basis of Social Justice in Contemporary China" sponsored by Shanghai Pujiang Programs (2006-2008). Dr. Liu is an outstanding young scholar and his contribution to understanding of the structure and mechanisms of social stratification in contemporary China is based on his continuous efforts of getting to know everyday issues by investigation. His recent publications include "Institutional Basis of Social Stratification in Transitional China." (in Creating Wealth and Poverty in Post-Socialist China. ed. by D. Davis and F. Wang. Stanford University Press. 2008); 《中國城市的階層結構與中產階層的定位》(《社會學研究》2007年第6期); "A Power Generation Explanation of the Mechanism of Social Stratification in Contemporary China" (Social Sciences in China, English edition, 2006, Autumn Issue); "Strata consciousness in transition-era urban China" (Social Sciences in China, English edition, 2002, Spring Issue). Professor Liu is honored with "New Century Excellent Talent in University" by Ministry of Education of PRC.

Daniel Lynch

Dr. Daniel Lynch (Ph.D from University of Michigan) is Associate Professor of International Relations at the University of Southern California. Lynch currently is devoting most of his research energies to a long-term project examining how Chinese political and intellectual elites expect China will, or should, change in the years leading up to 2030. His broader research interests include the international relations of East and Southeast Asia; the domestic politics and foreign policies of China, Taiwan, and Thailand; comparative state-society relations; democratization; and state socialization into international society. Lynch is the author of two books: “Rising China and Asian Democratization” (Stanford, 2006) and “After the Propaganda State” (Stanford, 1999). His scholarly articles have appeared in such journals as the “International Studies Quarterly” and “The China Quarterly”. Lynch currently serves as Director of the USC Politics and International Relations Ph.D. Program and he is a member of the USC US-China Institute's governing Executive Committee.

In 2005, he was elected to become an Academician (the first Chinese academician) of the Pontifical Academy of Social Sciences at the Vatican in Rome. Professor Kuan is a member of the Academic Advisory Committee, the Institute of Political Science, Academia Sinica, Taiwan, and a member of the Board of Governors of Caritas Francis Hsu College, Hong Kong. He also serves as a member of the Hong Kong Catholic Board of Education and of the Board of the Holy Spirit Study Centre, Catholic Diocese of Hong Kong.

Dr.Kuan specializes in the study of political culture and development. He is co-author of several books, including *The Ethos of the Hong Kong Chinese* (Chinese University Press, 1988), *The 1995 Legislative Council Elections in Hong Kong* (Hong Kong Institute of Asia-Pacific Studies, 1996), and *Power Transfer and Electoral Politics: The First SAR Legislative Election in Hong Kong* (Chinese University Press, 1999).
